The 2011 Census

The national Census was carried out on 27 March 2011 and the results were released by the Office for National Statistics (ONS) from mid-2012 onwards.

Data from the Census survey gives an in-depth picture of the local population, housing, living arrangements and employment and is used by communities and public sector agencies to help plan local services.

Completing the Census form was mandatory and an estimated 97%¹ of the households in Vale of White Horse district completed their questionnaire on paper or the internet (across England the return rate was 95%).



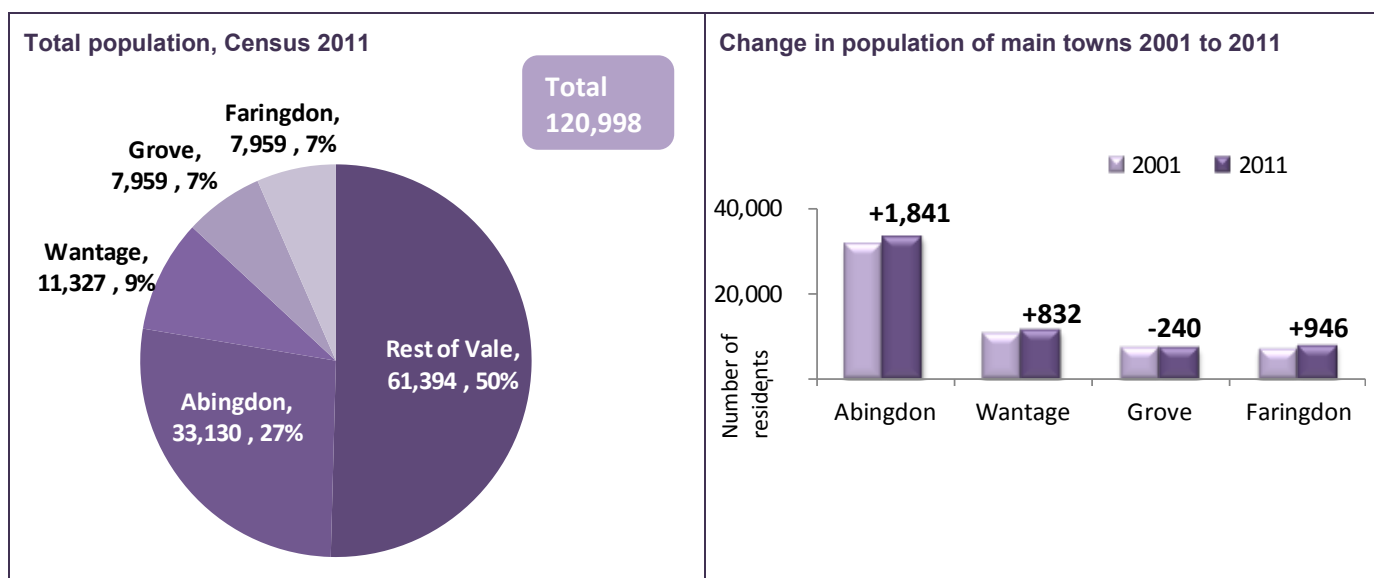
This leaflet provides a summary of the main findings of the 2011 Census survey for Vale of White Horse district and for the main settlements of Abingdon, Wantage, Grove and Faringdon. Note that the majority of this publication uses ward data and Faringdon ward includes the parishes of Great and Little Coxwell.

Further local area Census data is available for parishes, electoral wards and for smaller geographic areas including output areas (covering an average of 150 households) and super output areas (of up to 1,200 households). See *Finding out more* at the end of this leaflet.

Who we are – the population of Vale of White Horse

As of March 2011, there were **121,000** people living in Vale of White Horse district. This was up from the total of 115,600 residents at the time of the last Census survey in 2001, **an increase of around 5,300 (+5%)**.

The largest settlement in the district is Abingdon with just over 33,000 residents (see below). Abingdon has grown by over 1,800 people since 2001.

The size of the group aged 65 and over has increased significantly. From 1981 to 2011, the total population in Vale of White Horse increased by 18% (+18,400) while, within the same timescale, the population aged 65+ increased by 72% (+9,200).

In 2011, 3,000 people in Vale of White Horse were aged 85 and over representing 2.5% of the total population. This was above the national average of 2.2%.

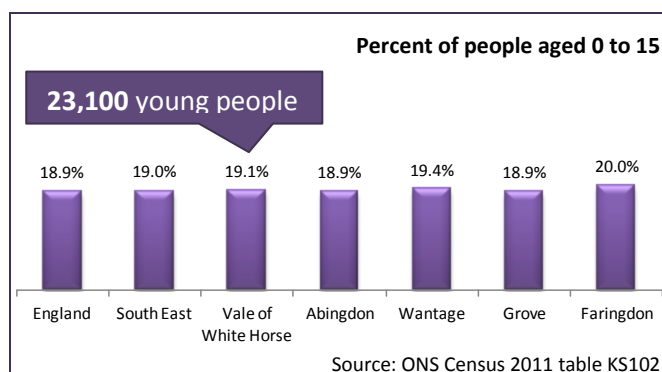

Who we are – in summary

Young people

As of March 2011, Vale of White Horse district had a similar proportion of people aged 0 to 15 (19.1%) compared with the regional and national averages.

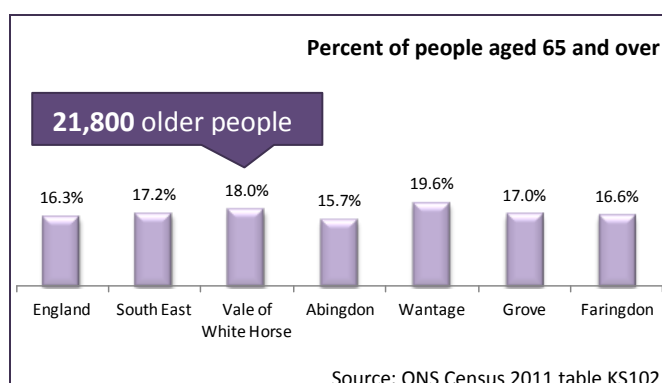
The proportion of young people living in the main settlements was similar to the district average.



Older people

The proportion of older people (65 and over) in Vale of White Horse was above average at 18.0%. The national average was 16.3%.

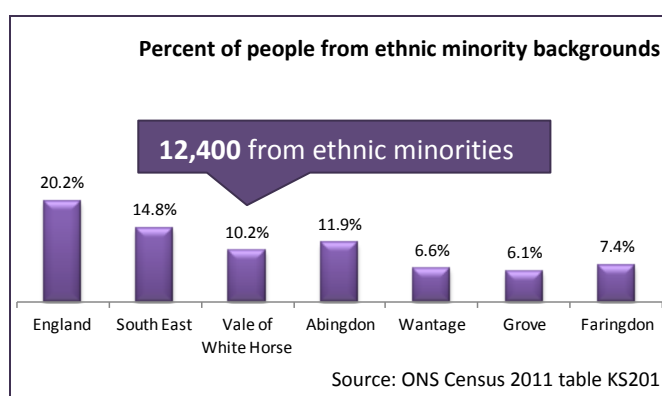
Abingdon had a below average proportion of older people and Wantage was above average. Grove and Faringdon were similar to the national average.



People from ethnic minority backgrounds

Vale of White Horse district had a relatively low proportion of residents from an ethnic minority (non-white British) background at the time of the census.

The largest ethnic minority group was 'other white' which made up almost half (42%) of the total ethnic minority population in Vale of White Horse.



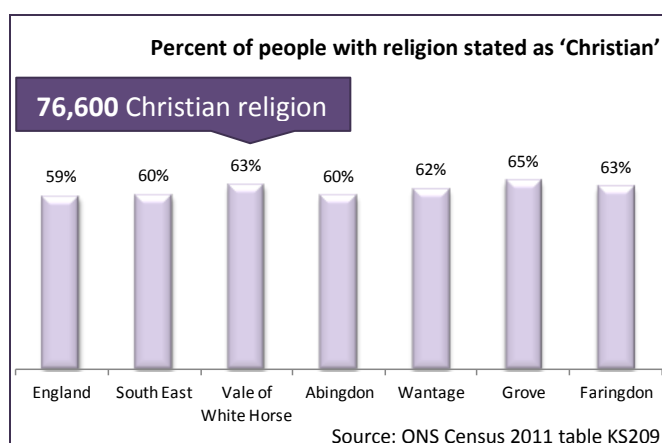
There were 12,300 people resident in Vale of White Horse as of March 2011 who were born outside the UK. Around 5,700 of these were from other European countries including Germany (1,190), Ireland (760) and Poland (670).

Religion

The largest religious group remains Christian with 76,600 residents or 63% of the population of Vale of White Horse.

The next largest group, over one quarter (27%), are those with 'no religion'. This was just above the national average of 25%.

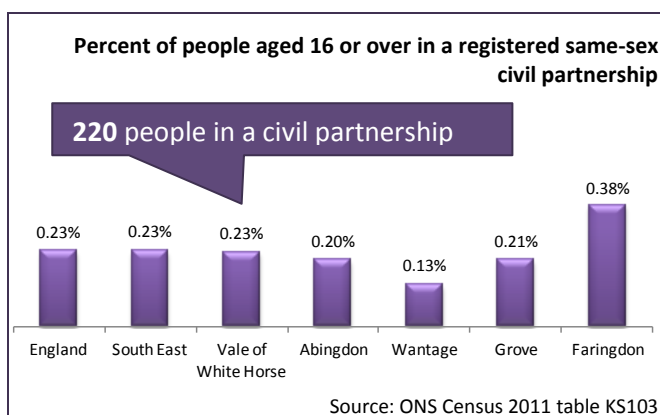
In Vale of White Horse, 2% of the population chose to state a minority religion with Muslim the largest group (1% of the total population).



Marital status

At the time of the Census, Vale of White Horse district had 55% residents who were married. This was above the national average of 47%.

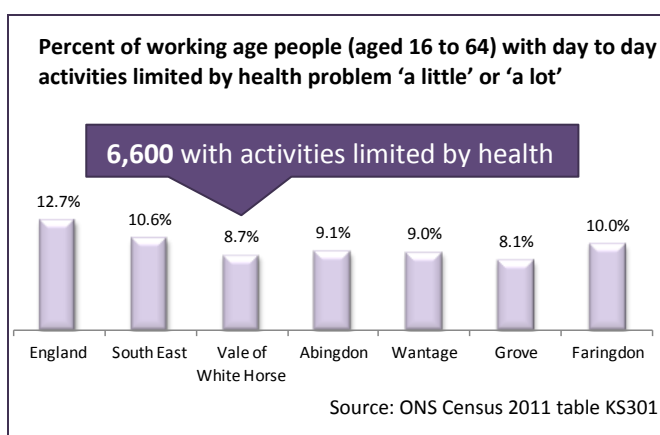
There were 220 people (0.2%) in a registered same-sex civil partnership in the district.



Working age people with activities limited by health

The working age population in Vale of White Horse is comparatively healthy with 8.7% of people aged 16 to 64 stating that their day-to-day activities were limited by a long term health problem or disability compared with 13% nationally.

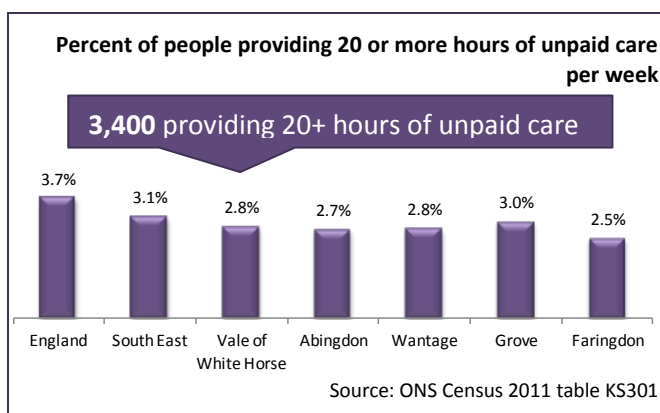
Abingdon, Wantage and Faringdon were just above the district average – i.e. having a less healthy working population than the district as a whole.



People providing unpaid care

There were 3,400 people in Vale of White Horse providing a significant amount of unpaid care (20 or more hours per week).

This represents 2.8% of the population, below the regional and national averages.



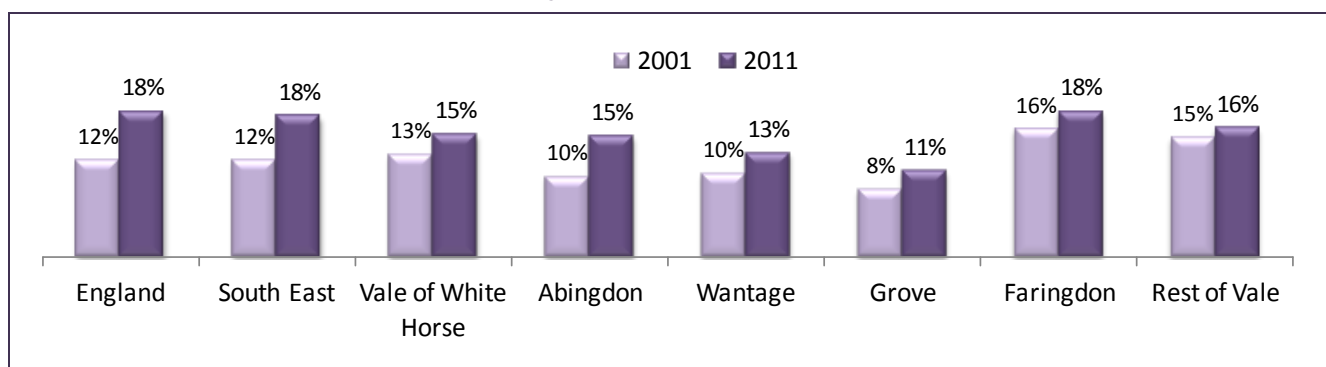
How we live – housing and living arrangements

As of March 2011, there were **49,400** households with at least one resident in Vale of White Horse district. This was up from the total of 45,800 occupied households in 2001, an increase of 3,650 (+8%).

There was an above average rate of owner occupation with 70% of households in Vale of White Horse either fully owned or owned with a mortgage. This was above the national average of 63%.

There has been an increase in the number of households that are rented privately, from 13% of the total in 2001 to 15% in 2011.

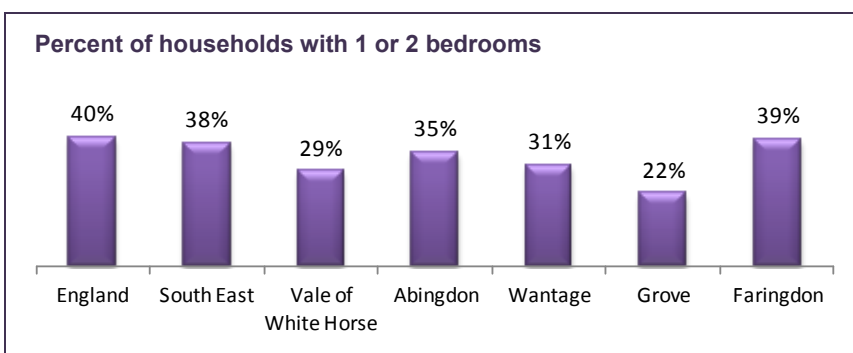
Percent of households that are rented privately 2001 to 2011

Information about number of bedrooms was included for the first time in this Census survey.

Vale of White Horse had a lower than average rate of households with 1 or 2 bedrooms, 29% compared with 40% nationally.

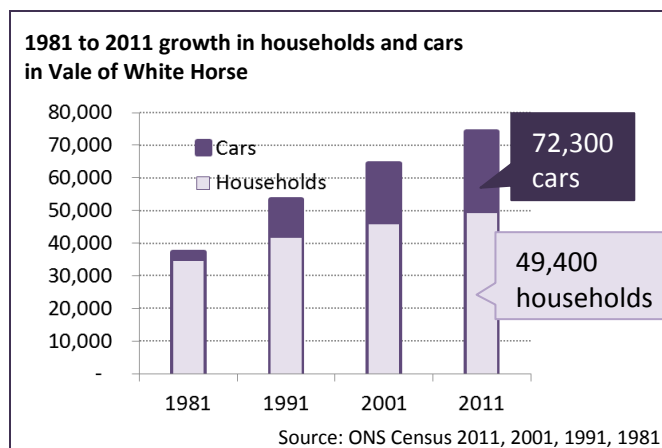
Of the 49,400 households in the Vale of White Horse, 5,900 (12%) were occupied by older people living alone (aged 65 and over), similar to the national average. There were 2,400 (5%) households occupied by lone parents with dependent children, below the national and regional averages.

Car ownership

Over the past 30 years, between 1981 and 2011, the number of households in Vale of White Horse increased by 42% while the number of cars owned by residents increased by 99%.

The number of cars per household increased from 1.07 in 1981 to 1.50 in 2011.

The rate of 1.50 cars per household in Vale of White Horse is above the national average of 1.16.

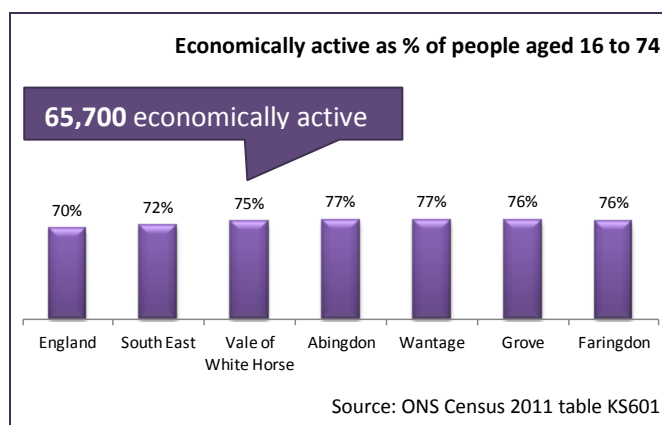


What we do – economic activity and employment

Economic activity

In Vale of White Horse, 75% of residents aged 16 to 74 were economically active (including full and part time employees, self-employed and unemployed)

This was above the national rate of 70%.

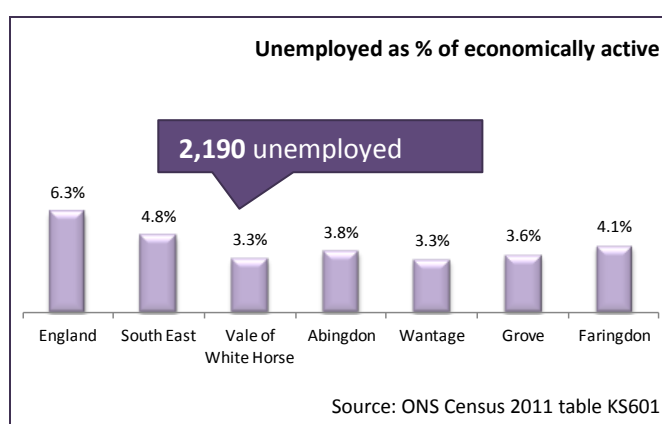


Unemployment

Unemployment in Vale of White Horse at the time of the 2011 Census was around half of the national average. Of the economically active population in Vale of White Horse, 3.3% were unemployed compared with 6.3% nationally.

Unemployment in Abingdon and Faringdon was above the district average.

Of the 2,190 unemployed in March 2011, 27% (592 people) were in the age group 16 to 24. This was just below the national average of 28%.

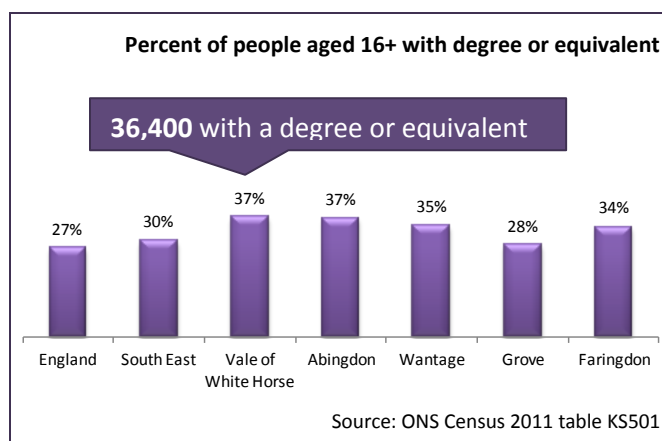


Qualifications

People in Vale of White Horse are relatively well qualified.

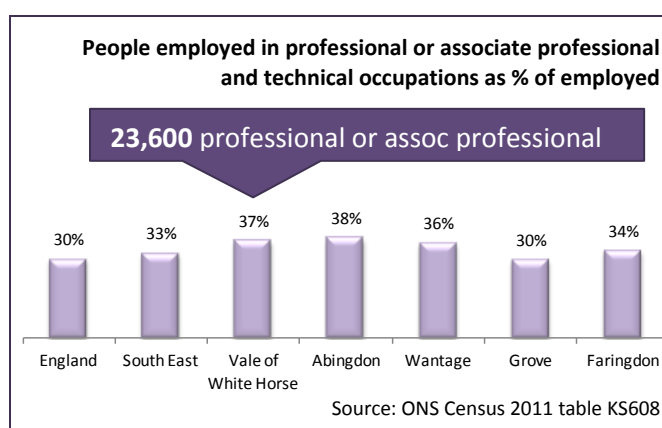
Over a third (37%) of people aged 16+ **had a degree or equivalent** in Vale of White Horse district. This was well above the national average of 27%.

Just over 16,000 residents (17%) aged 16 and over in Vale of White Horse had **no qualifications**, below the England average of 22%.



Occupation

An above average proportion of residents of Vale of White Horse were employed in professional or associate professional and technical occupations (37% compared with 30% nationally).

National Statistics policy is that estimates published for any geographical area are aggregations of whole output areas, the lowest geographical level for which census estimates are produced. This ensures that estimates can be released for any area which contains at least one output area, and contains the minimum population to ensure confidentiality (100 persons and 40 households). Some parishes in Vale of White Horse district have a very small population and have been assigned to a corresponding output area.
